OVERVIEW Cuyuna Outfitters is interested in receiving clean and fully functional outdoor gear and clothing for resale within our new gear exchange consignment program. We conduct tests to ensure cleanliness and functionality. Assessment factors include age, wear, inventory needs, brand appeal, demand, repair costs, and potential resale value. Cuyuna Outfitters reserves the right to decline gear based on these criteria. Defective gear may be disposed of at our discretion.

Unless explicitly communicated in writing, Cuyuna Outfitters welcomes items for consignment within a 90-day period. Should your gear remain unsold beyond this timeframe, please arrange for item pickup within 2 weeks. Unclaimed items may be handled at our discretion, including selling, donating, or disposing of them. Consignors at Cuyuna Outfitters are welcome to propose pricing, though the final price is at our discretion based on market factors. Once accepted, our team will efficiently tag and showcase your gear on the sales floor and may also list through our online sales Channels. Following a two-season inventory plan, Cuyuna Outfitters may introduce sales and markdowns, resulting in potential discounts for your gear. Please be aware that consignors will not be notified of these pricing adjustments. For example, Winter items could be discounted in March, and Summer items in September. If you have any issues with these terms - please do not use this service.

PAYMENT

Cash Payment: Once your gear finds a new owner, the credit will be tracked in your consignment account. If your account surpasses \$40, you can request printed checks at any time. Keep in mind that checks will be void after 180 days and won't be reissued. After two years of inactivity, account balances transition to store credit. If you prefer, you can request a mailed check after the 90-day period for a \$2 fee.

Store Credit: To maximize your payout you can opt to receive store credit instead, which will be value for the purchase of new gear from Cuyuna Outfitters. If we don't have what you are looking for, talk to us about a special order through one of our vendors.
